2) DECLARATION OF INTERESTS

JB, AA & AMc declared a non-prejudicial interest as a member of Kirklevington Action Group (KAG). JB declared a non-prejudicial interest as Treasurer of Kirklevington Memorial Hall. AA declared a non-prejudicial interest as Chairman of Kirklevington Memorial Hall. JB showed a non-prejudicial interest as a close neighbour of planning application 21/0156/FULt.DH declared a non-prejudicial interest as employed in a Government Department. AS declared a non-prejudicial interest as a member of SBC Planning Committee.

3) MINUTES OF THE LAST PARISH COUNCIL MEETING

4) MATTERS ARISING MINUTES

12c) 18.10.2021 – Remembrance Service, Kirklevington.

NDB represented the Parish Council at the Remembrance Service that was held at St. Martin and St. Hilary's Church, Kirklevington and laid a wreath on behalf of the Parish Council.

5) QUESTIONNAIRE

DH has been working through the returned questiionnaires. A number of residents requested a book swap facility, fitness equipment and a playgroup. Residents commented on the lack of consultation in relation to the proposed Ward Boundary Changes. On the downside, many residents commented on the speeding traffic within the village and the village being used as a rat run. A lot of positive comments had been received and particularly with regard to the newsletter keeping everyone informed.

6) PUBLIC RIGHTS OF WAY ISSUES

NDB reported that A. Smuk of SBC needs to give some indication and timescale for getting the drainage issues at the PROW sorted. The PROW path which is in urgent need of work – Borough Councillors are happy to fund the work from their transp ort budget The scope of the work needed and specifications for the work are been looked at. **AS** to looking into the quote and timescale for the work from SBC.

7) PLANNING

a) PLANNING UPDATE

i) Story Development

- It would appear that Jomast have advertised for a company to take over the
 approved shop but it would appear that residents who made enquiries re the
 possibility of using the shop have not been considered. This has been looked into by
 SBC and they have confirmed that it had been advertised but we are unsure as to
 where the advertisement was placed. It would appear that is unlikely that the
 development of the shop will go ahead and we await confirmation.
- **NDB** reported that he had been in dialogue with Mark Green of Story Homes re various issues footpaths, lighting etc.
- **NDB** reported that questions are being asked by residents living on St Martins Way as to whether the swale will be adequate through the winter months to cope with the winter rains.

ii) Banks/Taylor Wimpey - 21/0156/FUL

AA to attended the SBC Planning Committee meeting on the 24th November. KAG had held a meeting in prepartions with presentations organised and ready. New drainage plans have been submitted by Banks/Taylor Wimpey with suds at the northern area of the site and pipes going through 2 residents gardens on Westlands. A letter has been sent to these residents from Banks/Taylor Wimpey. There is a concern that these residents are unaware of what is involved and that there is a need for their willingness to consent.

NDB reported that with regard to the alternative means of access to the site the
Officers Report to the Planning Committee did not correctly inform of the situation.
The subject of the alternative access is not closed by the landowner and that they are
still open to discussion.

iii) Theakstons

A.S reported that at the beginning of the Public Enquiry the Q.C's gave opening submissions. The first day saw submissions from both sides. Their had been a site visit. The main issue was the proposed widening of Leven Road. SBC did not raise the issue of traffic on to the A67, Crathorne Interchange or pedestrian safety. The meeting was surprisingly closed on the 2nd day of the Public Enquiry which gave no opportunity for additional submissions on the 3rd day.

The Parish Council had previously spoken to Mark Green at Story Homes to see if a beacon could be placed on their green area but, unfortunately, had received no reply. However, we have now received an email from Mark Green and he is supportive of proposals and asked what is needed from them, which is great news. The Parish Council now need to look at this proposal in more detail.

a) Maintenance and Repair:

Unfortunately the carousel had to undergo some urgent maintenance as a peg had been wedged in the mechanisum and the carousel no longer moved. It had been observed that a white rabbit with floppy ears was seen pushing the peg into the carousel (pyjama day at the local school).

b) Equipment

All equipment has now been delivered and is in the process of completion. Top soil and turf is still needed to complete the seating areas. A sign still needs to be obtained which will replace the existing sign at the front entrance to the Play Area. The possibility of a bike rack was discussed which could be used by the children rather than them just laying them at the entrance.

13) VILLAGE ISSUES

a) Christmas Event - Saturday, 11th November

A budget of £250 was **approved – NDB, DH** to cover the cost of refreshments and selection boxes. The choir are to sing around the Christmas tree in the Play Area – weather permitting before all are invited into the Village Hall for refreshments. Father Christmas has been contacted and will give gifts of Selection Boxes to the children.

b) Halloween Trail

It was reported that the Halloween Trail had been well attended with so many families decorating their gardens. The winning homes were: 1st Prize – 22 The Green, 2nd Prize Orchard House, Pump Lane and 3rd Prize 8 Moor Close.

c) Levington Court Issues

NDB reported that the management company – Parker Barretts have now replaced the lighting and are working on other issues that need attention. Residents are now working with the management company.

14) ROAD SAFETY MATTERS

a) Traffic Calming, Forest Lane

NDB repeated that we already know the issues on Forest Lane with speeding cars

b) Service Bus Provision.

AS confirmed that the occupation of the 50th dwelling at the Story Homes development triggers the provision of the service bus. At this present time there are between 30 and 40 dwellings complete with many now occupied. However, it would appear that the figure being used is the number of homes paying community tax which, at this present time, appears to be only 17. **NDB** confirmed that there is a urgent need for the no. 7 bus service to begin for the benefit of all residents.

c) Lateral Margins Forest Lane

JS drew the attention to the fact that the lateral margins on Forest Lane as far as the county boundary to the west are very deep and dangerous to motorists and walkers. These need to be filled in and the **PC** to contact SBC.

d) Kirklevington Sign

JS also drew to the meetings attention that the Kirklevington sign on the western entrance to the village by the railway bridge is very small and needs changing. The PC to contact SBC.
