5) BOUNDARY WARD CHANGES - STOCKTON ON TEES

It was reported to the meeting that an email giving the views of Matt Vickers MP were given to the meeting. An expressed of disappointment was made by all Parish Councillors present.

Following the advertsing of the vacancy for a Parish Councillor by SBC with nobody coming forward, Terry Collins had expressed an interest and joined the meeting. NDB reported to the meeting that, in addition to the newsletter, it was his intention to open a Facebook page for the village which will, hopefully, enables access to more residents within the community to remain informed and up to date with issues and events. The site will be controlled and clarification that all who sign up to the site are Kirklevington residents. It's success will be monitored.

8) PLANNING

a) PLANNING UPDATE

- i) Story Development NDB reported to the meeting:
 - Markings on the road to indicate that Pump Lane is one way and that the NO ENTRY sign needs to be close Squirrels Leap and in larger print.
 - Markings need to be burnt off prior to being corrected.
 - Dropped kerb still need to be corrected.

- Water still remains very deep in the drains and potentially very danagerous
- Drainage levels still need to be corrected as the drains put in by SBC and the drains put in Story are at two different levels. Mark Green of Story had indicated previously that is the intention of Story Homes to realign the pipes. Major safety issue. SBC are aware of these issues and an urgent email to John Stockill of SBC to be sent.
- Start Times at the site:
 - a) Elaine Atkinson of SBC is looking at the legal issues re the start times
 - b) **JB** stated that the time that site workers and equipment enter the site shoulde be seen as the start time and not the actual time that they start up their vehicles and begin work.
- **JB** raised concerns re the large mound of soil which was close to the PROW on St, Martins Way and the possibility of water run off affecting adjoining homes and their gardens.

ii) Taylor Wimpey - NDB reported:to the meeting:

- The barriers have now been placed around the St. Martins Way site.
- Still waiting to hear if they will be using an alternative route to access the site which would avoid construction traffic accessing the site via St. Martins Way. **AS** reported that it had been reported that they were still in discussion.
